



# Friendly-Frets In-Person Lesson Policy

Updated March 1st, 2022

## Vaccination Status:

- **Proof of vaccination is required for all students who wish to take in-person lessons at my home studio.**
- **Proof of vaccination is required of all friends and family members who plan to accompany their student during their in-person lessons.**
- **Written proof of vaccination must be submitted to me prior to our first scheduled lesson.** Students/Parents may email/text a photo/PDF copy of their vaccination card to me directly or upload it in the website registration form.
- I have been fully vaccinated and will share my vaccination card with students/family members upon request.

## Masks/Social Distancing:

- **Mask wearing is mandatory in my home/lesson studio - No Exceptions.** Parents, students, and myself, must wear a mask fully over their nose and mouth at all times. Extra masks are available upon request.
- **2-Person Occupancy Limit:** No more than 2 people of one family/household will be allowed in the lesson studio at one time. Parents and family members are welcome to wait in the entry way waiting area just outside of the lesson studio.

**Reporting Symptoms:** Please contact me to reschedule your lesson (or request to meet online) if you, or members in your household, have experienced the following symptoms within 24 hours of your scheduled lesson<sup>1</sup>:

- **Fever or chills**
- **Cough**
- **Shortness of breath or difficulty breathing**
- **Fatigue**
- **Muscle or body aches**
- **Headache**
- **New loss of taste or smell**
- **Sore throat**
- **Congestion or runny nose**
- **Nausea or vomiting**
- **Diarrhea**

## Additional Health Precautions

- **These policies and procedures are subject to change according to WA State guidelines** <sup>2</sup> I will do my best to update student's and families in a timely manner.
- I will maintain safe distancing (3' - 6' feet) between myself and students/parents.
- Hand-sanitizer is available to students/parents upon entry.
- I will be running a Medify MA-15 Air Purifier with an H13 HEPA filter in the studio at all times during lessons.
- All surfaces occupied by students/family will be wiped down after each lesson. (This includes student chair, music stand, instruments, guitar picks etc).
- I will contact students/families to reschedule lessons if myself, or one of my family members becomes sick with covid related symptoms.
- Weather/Noise permitting: I may keep window(s) open for increased air-flow.
